The Cheyenne County Fair board held a meeting on Monday March 10, 2025 in the Cheyenne County Fairboard office at 10955 Hwy 30, Sidney, Nebraska. A notice of this meeting was published on 3/6/25, at the Sidney Sun Telegraph, the Cheyenne County website and Cheyenne County bulletin board. Copies of the agenda were transmitted to each Fairboard Member. Minutes are kept current and available to the public at the Cheyenne County Clerk's Office.

### Order of Business:

Arena Drag - Filsinger suggested that the board consider purchasing a Black Widow implement to drag the arena. This finishing implement levels the ground quicker and more efficiently than our current implements. It will be a tremendous time saver for raking between barrel racers and the Rubber Check Race. The discussion was tabled so that more information can be obtained.

Derby Car Raffle - Oliverius suggested a derby car raffle. 50/50 Raffle tickets will be available for purchase (price TBD) and the winner will be drawn during the Rubber Check Race, Wednesday July 23, 2025. The winner will be a contestant in the 90's and newer division of the Demolition derby. Dayson Contratto has offered to build and donate the derby car.
