The Board reviewed an application for General Assistance from Curtis Tucker for a County burial for Beverly Ann Tucker. Cheyenne County Attorney Amber Horn previously reviewed the application and it was her opinion that the application should be denied based on the Guidelines established by the County for general assistance. Section 5-201 states, in part, that if the responsible relative has made financial arrangements to provide for the services, the application will be denied. The amount of funds paid to the funeral home was \$1,820.00. A motion was made by Sanders, seconded by Miller to deny the application for assistance. Roll Call: Aye: Sanders, Johnson, Miller. Cheyenne County Tourism Director Kendra Mitchell discussed with the Board proposed changes to the following documents: Visitors Committee By-Laws, Tourism Director Job Description, Visitors Committee Member Job Description, Visitors Committee Member Application, Grant Guidelines and Policies and Grant Agreement Templates. The proposed changes are as follows:

By-Laws

Term limits were Introduced (maximum of two successive terms). Regular meetings were shifted to a quarterly schedule with an additional special meeting for budget review and clarified the role of the Tourism Director in relation to the Visitors Committee.

Tourism Director Job Description

Responsibilities for grant administration were updated. Oversight of the Visitor Center and active participation with the Visitors Committee were added.

Visitors Committee Member Job Description

Added a new document outlining duties, expectations and structure for Committee members.

Visitors Committee Member Application

A new document standardized the process for individuals applying to serve on the Visitors Committee.

Tourism Grant Policies and Guidelines

The Event Incentive Grant was removed and a new Facility Promotion Grant was added. Grants will now be reviewed on a quarterly basis. Both Event and Facility Promotion Grants require a 25% match and must demonstrate a marketing reach of at least 50 miles.

Grant Agreement Templates

A new process component was added. Each grant type now includes an agreement specifying funded items, grant acknowledgment/crediting requirements and deadline compliance.

After a discussion, a motion was made by Miller, seconded by Sanders to table this matter to the April 21, 2025 meeting to allow the Visitors Committee to reconvene and begin having Committee meetings. Cheyenne County Attorney Amber Horn will chair the first meeting for the purpose of electing a Chairman and Vice-Chairman. Roll Call: Aye: Johnson, Miller, Sanders. Nay: None.

Brenda Blanke began by stating that the Safety Committee would like to hold AED and CPR trainings for the County employees. The date would be May 13th and there would be 2 sessions, one in the morning and one in the afternoon. There would be a limit of 48 employees who could attend. The cost would be \$27.00 per attendee and \$40 for the room rent at Western Nebraska Community College. Chad Engle from NIRMA will provide the trainings. A motion was made by Miller, seconded by Sanders to approve the trainings. The cost of the trainings will be paid from the Safety Committee budget. Roll Call: Aye: Miller, Sanders, Johnson. Nay: None.

Joe McCarn, Cheyenne County Chamber Director, presented the quarterly report of activities of the Cheyenne County Chamber of Commerce.

Cheyenne County Highway Superintendent Skylar Saucedo updated the Board on road activites.

Kevin Sylvester who prepared the 2023-2024 Cheyenne County Audit, discussed with the Board the Audit. A motion was made by Miller, seconded by Sanders to approve the Audit as presented. Roll Call: Aye: Sanders, Johnson, Miller. Nay: None.

There were no comments from the public.

At 9:40 A.M., a motion was made by Miller, seconded by Sanders to enter into executive session to discuss Court House security. Roll Call: Aye: Johnson, Miller, Sanders. Nay: None.

At 10:30 A.M., a motion was made by Miller, seconded by Sanders to exit executive session. Roll Call: Aye: Miller, Sanders, Johnson. Nay: None.

There being no further business to come before the Board, the meeting was adjourned at 10:30 A.M.
