The Board reviewed Monthly Fee Reports for the month of December for the Clerk, Clerk of the District Court and Highway Superintendent and for the months of November and December for the Treasurer and Sheriff. A motion was made by Sanders, seconded by Miller to approve the Monthly Fee Reports as reviewed. Roll Call: Aye: Sanders, Johnson, Miller. Nay: None.

The Board reviewed an application for General Assistance from Xena Gallaher for a County burial for Gary Lee Ellis. Cheyenne County Interim County Attorney Amber Horn stated that the financial status of Mr. Ellis' estate was investigated. There were no assets in the estate of Mr. Ellis. Accordingly, a motion was made by Sanders, seconded by Miller to approve the County burial for Gary Lee Ellis as requested. Roll Call: Aye: Johnson, Miller, Sanders. Nay: None.

The Fair Board submitted a request to have Travis Sprenger appointed to serve on the Cheyenne County Fair Board to fill a vacancy on the Board. The term of the appointment is from February 3, 2025 through December 31, 2026. A motion was made by Sanders, seconded by Miller to approve the appointment of Travis Sprenger to the Fair Board with his term to run from February 3, 2025 through December 31, 2026. Roll Call: Aye: Miller, Sanders, Johnson. Nay: None.

Joe McCarn, Cheyenne County Chamber Director, presented a quarterly report on the activities of the Chamber.

Jamie Bright, Extension Educator, presented the annual report for the Nebraska Extension.

Kendra Mitchell, Cheyenne County Tourism Director, discussed an event incentive grant from the City of Sidney for Downtown Sounds in the amount of \$7,500.00. On January 8, 2025, the Visitors Committee approved the grant in the amount of \$4,500.00 with a vote of 3 to 1 in favor. The total of the event receipts submitted by the City of Sidney was \$7,500.00. According to the grant guidelines, the most that can be reimbursed is 20% of the total receipts submitted which would be \$1,500.00. After a continued discussion, a motion was made by Sanders, seconded by Miller to approve the amount of \$1,500.00 as reimbursement to the City of Sidney based on the 20% of \$7,500.00. Roll Call: Aye: Sanders, Johnson, Miller. Nay: None. The Sun-Telegraph reported that the word "illegal" was quoted as being said by a member of the Visitors Committee. The Commissioners were adamant that there is nothing illegal being done by the Visitors Committee and it was a poor choice of words.

The Board felt the By-Laws and the grant guidelines for the Visitors Committee needed to be restructured and the Visitors Committee should be suspended pending research of the existing By-Laws and grant guidelines. Tourism Director Mitchell stated that speaking with other Visitors Committees could be advantageous. Commissioner Miller stated the job description and the duties of the Tourism Director also need to be revamped. A time frame of 2 months in which to complete these tasks was suggested. A motion was made by Sanders, seconded by Miller to temporarily suspend the Visitors Committee until further notice. Roll Call: Aye: Johnson, Miller, Sanders. Nay: None.

Skylar Saucedo, Cheyenne County Highway Superintendent, updated the Board on road activities.

There were no comments from the public.

There being no further business to come before the Board, the meeting was adjourned at 8:53 A.M.
